



Policy Title: **Student Academic Dishonesty**

Policy Number: PS 1035

Purpose of Policy: To provide Bellevue University's statement of expectations concerning academic honesty and to provide policy and procedures for faculty when administering disciplinary action to students engaged in academic dishonesty.

Applies to: All Students, Faculty, and Staff

Policy Statement:

1. Overview:

- a. Bellevue University is committed to academic excellence. The University expects academic honesty from all members of the University community and believes that it is essential for academic excellence and integrity. Academic honesty includes adherence to guidelines established by the instructor in a particular course for both individual and group work. It prohibits representing the work of others to be one's own (plagiarism); receiving unauthorized aid on an assignment (cheating); and using similar papers or other work product to fulfill the obligations of different classes without the instructor's permission.
- b. Penalties for academic dishonesty may include a warning, a reduction in grade, a grade of "F" on the work in question or, with Dean approval, a grade of "F" for the course. In addition, any student engaged in academic dishonesty may be subject to disciplinary action including reprimand, short-term suspension, long-term suspension, and/or expulsion according to the policies and procedures of the University.

2. Process:

- a. In the event an instructor believes an incidence of academic dishonesty has occurred, the instructor will inform the student of his or her belief and will discuss the incident with the student, give the student an opportunity to provide an explanation, and discuss what associated disciplinary action will be initiated, if any, prior to instituting any disciplinary action against the student. If the student provides an adequate explanation to the

satisfaction of the faculty member, the matter will be deemed resolved. If, in the opinion of the faculty member, an adequate explanation is not provided by the student, the faculty member may sanction the student in accordance with the Academic Dishonesty Penalties section of Policy Statement 1901, Student Code of Conduct. The faculty member is responsible for documenting this decision and notifying the Dean of Students' Office. After determining an incidence of academic dishonesty has occurred, the instructor will then create a record of the incident that includes the offense and the faculty sanction imposed. The faculty member must promptly notify the Dean of Students' Office by forwarding a copy of the record, including the student's ID and the course, to the Dean of Students' Office via the Student Experience Feedback and Complaint Form, who will act as a depository and resource for all disciplinary documentation. The Dean of Students' Office is also responsible for notifying the student of the decision, the sanction being imposed, and the right to appeal.

- b. The Dean of Students will review the documentation and the student's record for multiple incidents of dishonesty. If multiple incidents of dishonesty exist, the Dean of Students will provide copies of the records associated with the incidents to the Dean of the college in which the student is enrolled.
- c. The Dean of the college will use the policies and procedures within his or her college to further review the incidents of academic dishonesty to determine if any further disciplinary action is warranted.
- d. A student may appeal any determination of an incidence of academic dishonesty, or disciplinary action initiated in conjunction therewith, by the same appeal procedures as set forth in the Student Code of Conduct.
